The new data protection law came into force on May 25, 2018.

This law brings with it some changes. In the past, we were able to automatically send you our magazine with the updated member list every 2 years. That doesn't work anymore.

Member lists are only given to board members and other members who perform a special function in the GK that requires knowledge of member data.

If a member claims that he needs the list of members to exercise his statutory rights, the board will only hand over the list against written assurance that the addresses will not be used for other purposes.

Exercising my statutory rights, I apply for the delivery of an updated list of members and assure that the data contained therein will not be published or used for other purposes.

Data protection

We would like to point out that the data provided in the "Application for membership in the Society for Orthodontic Dental Technology e.V." and in the registration flyer for the Harz training seminar are recorded and stored in the association's own IT system by the 1st and 2nd chairman, the treasurer and the secretary become. Each club member is assigned a membership number.

The personal data is protected from knowledge by third parties by appropriate technical and organizational measures.

Other information and information about non-members are generally only processed internally by the GK board if they are useful for promoting the association's purpose (e.g. organization and implementation of the Harz training seminars, "GK - on the wrong track") and there are no indications that the data subject has a legitimate interest that conflicts with the processing. When a member leaves, their last name, first name, address and year of birth will be deleted from the member list.

Personal data of the departing member that relates to cash management will be retained in accordance with tax law for up to ten (10) years from the written confirmation of the resignation by the board.
